## LIFE MEMBERSHIP POLICY PORT ADELAIDE DISTRICT HOCKEY CLUB INC.

## 1. PURPOSE

This policy details the eligibility criteria that a person, being either a playing member or non-playing member, may at any General Meeting of the Club, in consideration of valuable services rendered by them to the Club, be elected a Life Member.

## 2. CRITERIA

Life Membership is the highest Award attainable to recognise the exceptional contribution of individuals to the PADHC. It is therefore only to be awarded in exceptional circumstances.

In considering the award of Life Membership, an individual must have demonstrated significant, sustained and high-quality service enhancing the reputation and future of the Club.

An outstanding contribution to the PADHC is one which:

- Results in the PADHC being substantially, demonstrably and positively changed by that contribution, and
- Occurs over a significant period of time (at least 15 years), and
- Required substantial and commendable personal input, and
- Can be clearly documented and corroborated.


## Points System:

In order to provide some components of objective measurement, the points system is to be used as an aid to assist in the evaluation of nominations. A score of at least 100 points should be sufficient for a nomination to be submitted for consideration. It is essential that the Club evaluates the points and adjusts where necessary.

| Position Held | Points (per year) |
| :--- | :--- |
| President | 12 points |
| Vice President, Secretary, Treasurer | 9 points |
| Assistant Secretary, other Committee position, Sub-committee | 6 points |
| Active club person (e.g. sustained volunteering/extraordinary contribution) | 5 points |
| Coach or Team Manager | 3 points |
| Player Member | 1 point |

Additionally, an individual's personal attributes must also have been taken into account when considering any nomination:

- The general attitude and overall demeanor of the nominee to ensure that the attitude is one that reflects a dedication to the values of the Club.
- Commitment to the principals of good sportsmanship.
- Valued leadership and good role modelling that reflects credit upon the Club.

These attributes apply in whatever role the nominee has participated in during their service in the Club.

## 3. NOMINATIONS

Nominations are to be submitted to the President and/or Secretary in writing. All nominations will be assessed for accuracy, validity, and merit. Nominations are to be submitted to the President and/or Secretary using Appendix 1.

## 4. CONSIDERATION

At such a time a nomination is accepted by the Management Committee, the nomination will be presented at a General Meeting of the Club. A two-thirds majority of those present at the General Meeting of the Club and voting shall be necessary to such election. Every Life Member shall be entitled to all privileges of a member of the Club during their life without any further payment, annual or otherwise.

## 5. REVIEW OF POLICY

The Club will review this policy annually or as often as it determines necessary and will make any changes it determines necessary or desirable.

## 6. ACCESS TO POLICY
